

MOU OF COOPERATION

Between

VTHR, KVIP, SMDEC2, and CRETECH**

Vietnam Hydraulic Engineering Consultants Cooperation JSC (HEC), Tri Viet Agricultural food Trading Production Company Limited (TRIVIE), Faculty of Electrical and Electronics Engineering of Ton Duc Thang University (FEEE of TDTU), Hanoi Society for Viet Nam – Korea Public Administration in Hanoi city (HASOVPA), Vietnam Biomedical Technology JSC. (DNA) Vietnam – Korea and Science and Technology Cooperation Center (VIKOSTEC), Vi Thanh Human Resource Development Association (VTHR), Korea Vietnam Incubator Park (KVIP), Small and Medium Enterprises Development Support Center 2 (SMDEC2), Environmental Industry Institute (EII) and Center for Research and Technology Transfer (CRETECH) agreed to establish a cooperative relationship. Cooperation to enhance of the partnership to develop of Smart Green Industry, Hi-Tech Agriculture and Blue Carbon related public project. The eight sides agree on the following contents:

1. The ten sides organize, promote and establish the co-operative, commercial, investable relations with Vietnam governmental agencies and locals; state and private companies for development of Smart Green Industry, Hi-Tech Agriculture and Blue Carbon.
2. The ten sides maintain and develop a cooperative relationship to promote the study, training and develop human resources.
3. The ten sides organize the exchange of technical experience in the field of Smart Green Industry, Hi-Tech Agriculture and Blue Carbon to organize conferences and seminars in Vietnam and Korea to create conditions for partners of the ten sides to connect and expand cooperation relations.
4. The ten sides regularly exchange and provide information on the fields of education and human resource development.
5. The ten sides develop an implementation plan to concretize activities related to this Memorandum of Understanding.
6. This Memorandum of Understanding takes effect from the date of signing and is valid for a period of three (03) years, made in ten (10) copies in Vietnamese and ten (10) copies in English. All copies having equal validity, each party keeps one (01) copy in Vietnamese and one (01) copy in English.


